CITIZEN'S PARTICIPATION

Lynne Cavazos commented about positive feedback she has received for the paving and driveways on Ridge Road in Pentwater Township.

Lee Hyslop asked if the Road Commission could do some maintenance on Jackson Road East of 126th Avenue in Crystal Township.

David Schmieding appreciates the "road plan" that he and Mark Timmer discussed this year. David presented a letter on behalf of the Ferry Township Board that Mark Timmer read aloud (see attached letter at the end of board meeting minutes).

Garry McKeen thanked the Road Commission for their support again this year for mowing the county parks and also appreciates the great help he received from Parks Board Member Dave Spitler.

Larry Doran commented he has been driving our county roads and thanked the Road Commission for the great job they have done.....looks wonderful.

Motion by Gowell and supported by Koch to accept all three (3) proposals and utilize the supplier in the best interest of the Road Commission for steel siding at the Road Commission Hart Garage.

Roll call vote: Gowell – yes; Koch – yes; Forbes – yes; Spitler – yes; Myers – yes. Motion carried.

CHAIRMAN MYERS NOTED THE OCTOBER 23, 2024 BOARD MEETING HAS BEEN CHANGED TO OCTOBER 30, 2024 (10:00AM).

QUARTERLY COMMITTEE REPORTS

<u>Personnel Committee</u> – Chairman Myers noted that Managing Director, Mark Timmer is looking at options for hiring an on-staff Engineer as well as a 3rd employee for the front office at the Hart Garage.

<u>Finance Committee</u> – Commissioner Forbes spoke briefly regarding a conversation she had with CRA (County Road Association of Michigan) Attorney, Ed Noyola looking at other funding mechanisms due to fuel taxes possibly becoming a "thing of the past".

<u>Buildings & Grounds Committee</u> – nothing to report.

<u>Community Relations Committee</u> – Chairman Myers commented the relationship the Road Commission has with the Townships has been a good partnership. Senator Bumstead toured Oceana County and he noted that Oceana County has some of the best roads and was impressed.

<u>Weighmaster Liaison</u> – nothing to report.

<u>Parks & Recreation Liaison</u> – Commissioner Spitler commented Crystal Township Supervisor, Lee Hyslop has been instrumental in helping to get more students involved in Crystal Township recreational opportunities.

Equipment Committee – Vice-Chairman Gowell noted the Road Commission is looking into leasing brushing equipment.

STAFF REPORTS

The State crew did sweeping, roadside cleanup, and Adopt-A-Highway pickup.

The M-20 and Hart crews patched various roads with the hot box, finished fog sealing, shouldered 126th Avenue, 176th Avenue, Ridge Road and Washington Road, and also shouldered Juniper Beach and finished spillways.

Traffic Services has worked on asset management, Miss Digs, Road Soft, permits, sign repairs, street name signs, supervised the sign crew, closures and detours for road and bridge work, marked roads for paint, and staked roads for crush and shapes.

Mark Timmer reviewed bills and finances with Finance/HR Director and Clerk, Adams finished Roosevelt Road Bridge, Rieth Riley paved Juniper Beach (from Ridge Road to the West), Hallack Contracting is crushing and grading Juniper Beach and Ridge Road, Rieth Riley is paving Ridge Road (from lake to Pentwater Township), and Hallack Contracting will begin crushing Roosevelt Road (192nd Avenue to Maple Island). The Road Commission did \$16 million in road work in 2024!!! Mark thanked Clerk, Renee Curtis for billing out the remaining MDOT budget for their Fiscal Year (ended September 30, 2024).

Mark Timmer spoke briefly on the following items:

- **MTF (Michigan Transportation Fund) is currently funded by license, registration and fuel tax.
- **Road Commission was awarded Critical Bridge Funding (grant awarded) for 2027 construction season for the amount of \$469,000.00.
- **Rieth Riley paved for Oceana County Road Commission twenty-three (23) days out of thirty (30) days in September.
- **Sign in sheet for Road Commission meetings.....visitors are not obligated to sign but we do like to know who attends. Let the office staff know if you do not want your name included in our minutes.

Chairman Myers asked if there was any further business to come before the Board. There being none, the Meeting was adjourned at 10:34 AM.
