Bids were received by 1:00 PM on Monday, February 20, 2023 to refurbish SS Bodies off of D-93 and D-95, add scrapers and wings and add an additional wing on one (1) truck.

## RESOLUTION NO. 1 – REFURBISH SS BODIES/ADD SCRAPERS and WINGS/PLUS EXTRA WING

Motion by Forbes and supported by Gowell to accept the bid from Truck and Trailer Specialties to refurbish D-93 and D-95 SS bodies, add scrapers and wings, and also one (1) additional wing for a total cost of \$231,167.00.

#### **STAFF REPORTS**

The State crew has been doing night patrol, snow and ice removal, patching, and anti-iced state routes and some major county routes in advance (for possible storm arriving today).

The M-20 and Hart crews have patched various roads with the hot box, snow and ice removal, tree removal, brushing, graded gravels, and durapatched.

Traffic Services has worked on asset management, Miss Digs, permits, Road Soft, sign repairs, street name signs, supervised the sign crew, and snow removal.

Mark Timmer reviewed bills and finances with the Finance/HR Director and Clerk, met with Township officials regarding 2023 road work and prepared estimates, attended the EGLE virtual brine meeting, received bids for refurbishing boxes and adding wings, received bids for emulsion and fog seal, attended a truck safety symposium, and worked with Engineers on road and bridge projects.

Chairman Myers asked if there was any further business to come before the Board. There being none, the Meeting was adjourned at 10:20 AM.
