David Schmieding asked the status on Shelby Road (132nd Avenue to Baseline Road). Managing Director Mark Timmer asked David to meet with him following today's Board Meeting.

Garry McKeen announced after 3 ½ years the Marshvill Dam project will begin (received the approval on Monday, April 22, 2024 from SHPO).

Lee Hyslop commented he had attended a meeting last week regarding farming and infrastructure.

Larry Doran thanked Mark Timmer and the Road Commission crew for the wonderful slag job that was done on 96^h Avenue (from Washington to Adams) in Weare Township. This road drives very nice.

Scott Beals commented that a permit for Apple Fest was submitted to the Road Commission. Mark Timmer replied that the Road Commission has received this permit request.

Managing Director Mark Timmer, Road Maintenance Coordinator Jeff Balkema, and North County Foreman Randy Smith recommend Corby Energy Services (CES) for the culvert lining because they have the MDOT contract.

RESOLUTION NO. 1 – CULVERT LINING MADISON ROAD

Motion by Forbes and supported by Gowell to have Corby Energy Services (CES) line a thirty-six inch (36") / one hundred twenty foot (120") long culvert on Madison Road for the amount of \$39,260.00.

STAFF REPORTS

The State crew did shoulder work, roadside cleanup, and patched various routes.

The M-20 crew graded gravels, patched various roads with the hot box, slag upgrades, and tree cleanup from recent storms.

The Hart crew graded gravels, patched various roads with the hot box, tree cleanup from recent storms, slag upgrades/prep work, prep work for paving, and prep work for bridge work (will be starting on the Buchanan Road bridge over Swinton Creek).

Traffic Services has worked on asset management, Miss Digs, Road Soft, permits, sign repairs, street name signs, supervised the sign crew, closures and detours for road and bridge work, upgraded signs in Elbridge Township, and Shelby Township Street name sign upgrade (Shelby Township is paying for these upgrades).

Mark Timmer reviewed bills and finances with Finance/HR Director and Clerk, congratulated Renee Curtis on her promotion to Road Commission Clerk (Renee is more than qualified for this position), Rieth Riley subcontractors began work on 192nd Avenue, Village of Shelby and MDOT authorized their portion of the work on Shelby Road/1st Street resurfacing (this has been awarded to Wadel Stabilization), received signed work order for \$1 million in road work from Golden Township, all work orders have been catalogued and sent to Rieth Riley and Hallack Contracting, and Hallack Contracting began work on Longbridge Road Fisherman's platform repair. Mark attended the MTA annual conference as a panelist on Roads and Relationships with partner from Golden Township, Connie Cargill (congratulations to Connie for becoming the new MTA President of the State). Brining is scheduled to begin the 1st week in May.
