STAFF REPORTS

The State crew has been patching various routes, storm cleanup, shoulder and drainage maintenance and mowing US 31.

The M-20 crew has patched various roads with the hot box, brined Shelby, Benona, Grant, Newfield, and working on Otto. Repaired washouts and gravel roads. Chip sealed and fog sealed, worked on drains, and shouldered Buchanan in Newfield, York, and Polk overlays, 116th in Otto.

The Hart crew patched various road with hot box. Brined in Golden, Hart, Crystal, Weare, Pentwater and working on Colfax. Repaired washouts and gravel – a lot of damage county wide with 4-6 foot trenches. Chip sealed and fog sealed, worked on drains and mowed county parks.

Traffic Services supervised sign crew/County Work/State Work, worked on asset management, Miss Digs, Road Soft, sign repairs, street name signs, permits, closures and detours for road work and bridge jobs. Gary McKeen commented that Jeremi did a great job on the detours.

Mark Timmer reviewed bills and finances with the Clerk. Pilings are all in on Roosevelt Bridge and building back walls. Rieth Riley finished paving Madison, road is shouldered, needs topsoil, guardrail and striping. York, 128th and Pierce is completed and open. Rieth Riley paved base on one line of Shelby Road, paved overlays on York and Polk for road bond. Prep work started on 116th in Elbridge, it is scheduled to be crushed the week of September 9th. Update on washouts and methods to repair the washouts. We also applied for and received an Intersection Sign Safety Grant for \$211,000.00 and we only pay \$21,000 of the total. Also, Senator Bumstead gave MDOT funding for a tunnel under M-20 by Lewis Farms that will accommodate pedestrian traffic and well as the trams. This project is in the planning stage for 2025.

Mark Timmer read a letter from Gary Leroy Strait which complemented the restoration of York, 128th and Pierce in Elbridge and Ferry Townships. Cathy Forbes said that North Ridge Road looks fabulous and Shelby Road also looks great. Mark said that Ridge Road will be improved from 34th/Deer Road to Longbridge Road.

Chairman Myers asked if there was any further business to come before the Board. There being none, the Meeting was adjourned at 10:19 AM.
